DUTIES:

This position is a tenure track instructor's position that will require teaching, support, and service within the Biological Sciences department. Primary teaching responsibilities include one lecture and four to five lab sections (per semester) in a large 2-semester human anatomy and physiology course serving pre-health sciences students. The lecture enrolls ~125 students in the fall semester and ~90 students in the spring semester. Lab sections are typically 24 students. The position is also expected to teach cadaver prosection as needed (usually every fifth semester) to a small number of qualified students (~5) and supervise care of the department's cadavers. Teaching other biological science courses is a possibility. Duties also include active contribution to the department in the form of service, examples of which include but are not limited to advising, assisting in department events, and recruiting.

REQUIRED QUALIFICATIONS:

- A minimum degree requirement of a M.S. degree, in Biological Sciences or in a closely related discipline.
- Biology teaching experience.

REQUIRED SKILLS:

- Effective oral and written communication skills; good interpersonal relationship skills.

PREFERRED QUALIFICATIONS:

- Ph.D. or ABD in Biological Sciences;
- Experience teaching human anatomy and physiology;
- Experience teaching anatomy and physiology labs using prosected cadavers;
- Experience in the care of prosected cadavers; experience in cadaver prosection;
- Demonstrated teaching excellence.
