## **IMPORTANT ZOOM UPDATES**

Zoom recently made some changes to their processes, You can learn more about the affected areas at the Zoom articles: New Meeting Join Flow and Customizing the Waiting Room.

In order to run Zoom going forward, you will need to be on Zoom **client version 5.12.0** or higher. The current version is 5.14.6. Sometimes, you need to uninstall the old version before you can install an updated version.

- 1. Type control panel in Search
- 2. Open Programs and features
- 3. Right click on Zoom
- 4. Uninstall okay

#### 2023 FISCAL YEAR-END PROCUREMENT INFORMATION

Fiscal Year End (June 30, 2023) is rapidly approaching. Your cooperation and timely processing of year-end purchases is important and appreciated in order to ensure that funds are spent in the appropriate fiscal year & that we have adequate time to process requests.

- · Purchase requisitions that require formal solicitation must be submitted by April 1,2023.
- · Purchase requisitions that require <u>limited</u> solicitation must be submitted by <u>April 15, 2023</u>.
- · Purchase requisitions that do not require solicitation must be submitted by May 1,2023.
- · Procard transactions that need to be expensed in FY23 must be completed by June 12, 2023.

· Invoices for FY23 must be submitted to Accounts Payable by June 12, 2023

Purchases of Software & I.T. Equipment (Computers, Tablets, Printers, Monitors, etc.) need to be coordinated through your I.T support Staff and requested no later than April 15, 2023 to insure the Purchase is completed for FY23.

- · Complete all Procard transactions for FY23 prior to June 12, 2023
- · June 13-June 30 will be a purchasing blackout period (Procards cannot be used Unless you are in travel status)
- · You can start using your Procard for FY24 expenses on July 1, 2023
