### **Action Items**

Jerry will put these nominations up for a vote on Survey Monkey.

- A motion was made and approved to use Survey Monkey to vote on the approval of the CRC minutes for meetings occurring 3/29 and 4/26.
- The Faculty Senate was asked to consider approval of some courses for meeting general education requirements. Chip Todd notes that he is here to help answer any questions that might come up regarding the courses, and thanks the senate and Jerry for putting this issue on the agenda. The goal is to put whatever courses end up being approved into the catalog for next year. The courses have been approved by the General Education (Gen Ed) Review Committee and the corresponding deans and departments. There was a lengthy discussion about music courses and about whether formal, graded, quantifiable, individual assessments of students' progress in Gen Ed courses are required.

A motion was made to put the courses approved by the Gen Ed Committee to a vote of the Faculty Senate using Survey Monkey. It was amended to specify that each course will be voted upon separately. Jerry Downey will make sure applications, syllabi, or other applicable materials for approved courses have been distributed to all members before the vote.

- Policy for Compensation of Academic Faculty Engaged in Research – Jerry notes that he has received comments from two departments. The senate decided to table this issue until next fall, when perhaps Maggie Petersen can attend a meeting to address comments and concerns of the faculty about the policy.
- Advising survey – Jerry noted that opinions expressed by departments and individual faculty members on a survey for the Advising and Retention Committee were numerous and diverse. Jerry will send these comments to the committee and will copy senate members so they can have a complete record of the diverse opinions expressed.
- MUSFAR – Montana University System Faculty Association Representatives – Jerry notes that the Faculty Senate has not participated recently in the MUSFAR meetings that typically occur in conjunction with Board of Regents (BOR) meetings. Since the next BOR meeting will be in Butte in September, Jerry feels it would be a good

opportunity to for a Montana Tech Faculty Senate member to participate. He asks members to consider serving in this role in the Fall and at future MUSFAR meetings. Jerry will put this on the August agenda to be revisited.

- Next year's Faculty Senate meetings are proposed to generally occur on the last Thursday of each month (beginning in August) at 7:00 am, with the exception of November.
- The Faculty Senate and Research Faculty has meetings scheduled on Tuesday, May 15 and Thursday, May 17 to meet with the two candidates for the Director of the Montana Bureau of Mines and Geology (State Geologist). All Faculty Senate members are invited and encouraged to attend these meetings. The meetings are scheduled from 1:30 to 2:15 each day in the Big Butte room.

The meeting was adjourned around 8:00 am.
