## Incoming Students

### Goal 1: Help Students succeed before they begin

- A. Advanced Registration March 27-Aug. 18
- B. Regular Registration Aug. 19-Aug 24
  - i. \$100 Late Registration Fee
  - ii. No new registration after 1<sup>st</sup> day of classes
- C. Add/Drop week Aug. 24-28<sup>th</sup> (ends after first week of classes)
- D. International Students **REQUIRED** to arrive one week before classes begin
  - i. Assures timely placement testing, avoids late registration fee, and ensures they attend orientation
- E. Accepting applications for current term stops 2 weeks before classes
- F. Students with incomplete applications have 1 week to complete
  - i. Assures timely placement testing, avoids late registration fee, and ensures they attend orientation

## Freshmen

### Goal 2: Gateway Course

- A. Students are guaranteed registration in gateway course for their major

### Goal 3: 20<sup>th</sup> & 40<sup>th</sup> Day Intervention

- A. Unsat/Sat grades only
  - i. If no data available faculty can choose either Sat (if you believe students start @ 100% or Unsat. if you believe students start @ 0%)
- B. **REQUIRED** to meet with Dir. Student Success, Dir. Fresh. Eng, Dir. Assoc. Sci. Prog.
- C. Students **REQUIRED** to take LASSI
  - i. Based on LASSI **REQUIRED** to attend minimum of one skills workshop/tutoring etc.
- D. Failure to comply results in **HOLD** on account until they meet with Dir. Student Success, Dir. Fresh. Eng, Dir. Assoc. Sci. Prog.

### Goal 3: 40<sup>th</sup> Day Intervention

- A. **REQUIRED** to meet with Dir. Student Success, Dir. Assoc. Sci. Prog. and Academic Advisor
- B. **REQUIRED** to take LASSI
  - i. Based on LASSI **REQUIRED** to attend minimum of one skills workshop/tutoring etc.
- C. Failure to comply results in **HOLD** on account until they meet with Dir. Student Success, Dir. Assoc. Sci. Prog.

### Goal 4: Academic Probation & Suspension

- A. Maximum of 12 credits
- B. Required to take MT1016- Tech Success
  - i. Students on their first academic probation
- C. **REQUIRED** to meet with Dir. Student Success, Dir. Assoc. Sci. Prog. **And/or** Dean of Students
- D. **REQUIRED** to attend 3 academic coaching sessions
  - i. 2<sup>nd</sup> probation & all re-admitted students
- E. Failure to comply results in **HOLD** on account until they meet with Dir. Student Success, Dir. Assoc. Sci. Prog. **And/Or** Dean of Students
